Some of the other issues that are on the horizon for Utah will include the expansion of aquatic nuisance species and activities to combat this expansion, additional water projects in adjacent states, and energy development with potential coal and hydroelectric plants being explored. Salt Lake City is even considering the adoption of building restriction to protect watershed and

When this need arises during the vear the executive committee often discusses such matters and votes on a course of actions. The alternatives may include no action, referring the matter to a subcommittee or taking action on the matter. When time provides, the matter is held for the annual business meeting. As we prepare for the business meeting to be held as part of the annual meeting, I would encourage each of you to take a few minutes to read through the bylaws. 
President's Message



Native fish research in a highly dynamic desert stream

he bluehead sucker (Catostomus discobolus), the flannelmouth sucker (Catostomus latipinnis) and the roundtail chub (Gila robusta) are three species native to the Colorado River Basin. As a result of habitat alteration, water diversion, and interactions with non-native fish, all three have declined in abundance and distribution, resulting in placement on the Utah Sensitive Species List. Populations of all three species are found in the San Rafael River, a tributary of the Green River, demonstrating the importance of this river in conserving remnant, genetically-pure populations. Compounding the problems of reduced abundances and distributions is the lack of information regarding life-history characteristics and habitat requirements, impairing efforts to adequately protect remaining populations. In the summer of 2007, we began an active mark-recapture approach combined with passive PIT-tag detectors on the San Rafael River to determine 1) habitat requirements for each species and life stage, 2) the timing and extent of spawning migrations and the prevalence of localized movement, and 3) vital rates such as growth and survival. Data collected on vital rates will trans-

late directly into a population viability assessment, highlighting vulnerable stages of development critical to the persistence of each species. Knowledge gained from this study will enable state and federal agencies to adequately manage these native species on a basin-wide scale and ensure their persistence in the future.


EXTERNAL COMMITTEES

Welcome-Paul Cowley

Introductions

We are now the Utah Chapter AFS, Bonneville is not in the title anymore.

Patrick-We should change the website to reflect this change.

Previous Meeting Notes approval: Patrick moves to approve minutes, Phaedra seconds. Unanimous vote to approve the minutes.

2008 MEETING Mike S.

Location and Food: Decided on Moab for the 2008 annual meeting. We will meet at Red Cliff lodge. Feb 25-27 (mon-wed) this choice seems like the most economically feasible one.

<u>Patrick</u>-must make sure there is adequate food and units for lodging for all the people we expect. We need to have at least 75 rooms to host all the people we expect for the meeting.

Mike S - would check on the room availability for the lodge. Discussion was given on meal options: The objective is to have people stay at the facility for meals. We would have to almost allow an hour and a half to go into Moab if people were to travel for meals. Discussion on the banquet possibilities. There are a lot of rooms available at reasonable prices. We discussed how many rooms would be available for concurrent sessions depending on numbers of papers that will be presented. Food will be mostly buffet style. Important Points:

There is limited cell phone coverage at this place.

No alcohol is allowed to be brought in from outside. There is some inside, but there is no outside alcohol allowed.

It was proposed that Aaron Webber be in charge of collecting dues, setting up meetings. Aaron accepted the responsibility. Aaron should talk to Shauna Levitt to see what she has done in the past and solicit some help from others to collect dues etc. The intent is to keep the costs under \$100 per person. We'll look at a break even point with 80 people.

Continuing Education-will it be available?

Brian-a meeting was held last week for the student subunit and a topic of fisheries statistics was going to be offered. Brian thinks 30-40 people would be able to go to the continuing education class.

Monday Night Social - It was decided that Monday night would be left up to the student social and no dinner would be provided. A concern was that if alcohol was consumed it is a long time back to the Red Cliff and there is potential for accidents etc. The Chapter will provide \$500 for the student social to help out. Everybody agreed.

T-Shirt/Sale Items - T-shirt- should we include a t-shirt in the fee for the meeting? Everybody thought that was a good idea and <u>Mike S.</u> was going to look into it. It shouldn't cost more than 3 or 4 dollars each.

Meeting Topics - What will the topic be for the meeting? Ideas on invasive species...quagga mussels? Maybe we should invite somebody knowledgeable about some of the Colorado River fishes since it is so close. Maybe a plenary session on quagga or invasive species or climate change.

Maybe Chuck Hawkins or Mark Vinson could talk. Patrick suggested something other than aquatic nuisance species should be talked about like bark beetles or tamarisk. He suggested that maybe it should be a little broader.

By mid October we should have a first call for papers go out to the membership

500.00 to assist in getting prizes for the raffle will be given. Everybody was in agreement. Send ideas for potential people that could get prizes for the raffle. Send those contacts to Mike Mills. Mike is looking for help for anybody that has contacts for donations.

Awards - Patrick G.

Lifetime awards etc. We need to get ideas for awards and nominees for awards to be given out in the organization. Patrick thinks a "rookie of the year" award would be good but lets get some new awards to change it up a little.

Nominations Ron will be in charge of receiving nominations for new committee members.

Photo Competition - Should there be a photo competition or a slide show? The group thought that would be a good idea, but somebody should be delegated to do it. Awards should be recognized that have happened in other agencies and announced at the meeting.

Budget Report Trina

Review and approval of notes from Sept 2007 meeting.

Addendums to notes. An amendment was made by Mike Slater that there was limited cell phone coverage at the Moab meeting place. Patrick motions to approve notes from last meeting. The motion was seconded. All were in favor.

It was brought up that meeting notes should be approved electronically before they are put in the lateral line. That was okay with everybody.

2008 Annual Meeting Discussion

Other Business

 Least chub request of the chapter to sign listing petition

Patrick received a request was made from Allison Jones to have the chapter sign the petition to list the least chub. It was noted that the species is under a conservation agreement. There was concern express that if the chapter supported the listing we may alienate the DWR. It may not be in the Chapter's best interest to support the petition. It was generally felt that we need to represent the resource and not the agency that we work for. We do need the feedback from our membership on these items.

We discussed the least chub listing and based on the response of the membership, A motion was made not to support or sign the least chub petition. It was unanimous.

2. 2008 Western and Parent Society Meeting Representation - Discussion was given about sending some of the committee members to go to national AFS meetings.

3. Report from the National AFS meeting. Patrick-It was a great meeting with 15 concurrent sessions. 4 usu talks were given. The parent Society passed a resolution to basically support only teaching evolution in schools.



Assessing the Relationships Among Broad-Scale Watershed Characteristics, Stream Habitat and Macroinvertebrates

here is a need to understand the current state of aguatic resource conditions within the Interior Columbia River Basin where Endangered Species Act (ESA) listed fish species occur. The Biological Opinions for Chinook salmon (Oncorhynchus tshawytscha), steelhead (Oncorhynchus mykiss) and bull trout (Salvelinus confluentus) call for a consistent framework for monitoring aquatic resources on Federal lands. In response to these Biological Opinions, the PACFISH/INFISH Biological Opinion, Effectiveness Monitoring Program (PIBO-EMP) was established to implement a monitoring program on Federal lands within the Interior Columbia River Basin. One of the objectives of the PIBO-EMP is to determine whether the aquatic conservation strategies of land management plans are effective in maintaining or restoring the structure and function of aquatic systems. To accomplish this objective, the PIBO-EMP measures instream physical habitat indicators at the reach scale to characterize the ecological condition of watersheds. While habitat surveys like those carried out by the PIBO-EMP provide a good assessment of watershed condition based on reach scale stream characteristics, the ability to assess conditions over a large geographic area such


as the Interior Columbia River Basin is limited by funding and personnel.

The objective of my project is to use the PIBO-EMP stream survey data to assess the relationships among broad-scale watershed characteristics, in-stream habitat and macroinvertebrate assemblages. I will use Geographic Information Systems (GIS) to characterize the variation in climate, geology, topography, land cover and natural and anthropogenic disturbance among watersheds and examine the relationships of these characteristics to in-stream habitat and macroinvertebrate assemblages using regression analyses, Classification and Regression Trees (CART) and Structural Equation Modeling (SEM). Results from this study should provide additional insight into the influences of broad-scale watershed characteristics on stream ecosystems and provide land managers with an efficient and cost-effective means to evaluate watershed and habitat conditions over large geographic areas.
